

- As the Visa Process may take some time, please hurry with your applications with full details.
- 2) All hotel rooms are taken on single occupancy basis. Twin Occupancy and Double Occupancy basis and will be allotted first come first served basis.
- 3) Accordingly, any delegate desirous of bringing his/her spouse will have to submit online registration form in similar fashion. Such delegate will have to pay for their spouses Rs 75,000 + GST @ 5% (=Rs 78,750/-) for Package I and Rs. 50,000/- + GST @ 5% (= Rs. 52,500/-) for PKG-II. This rate will hold good for the first 25 spouses' registration whose names have been **confirmed by FIMMDA** conference desk. Keeping in view of the limited availability of seats, registration for spouses may be closed at 25 numbers by FIIMDA. Once this limit is reached the spouse cost will change and will be displayed on our website. Spouses staying in another hotel & joining the delegate during local sightseeing, river cruise & other cultural events will be admitted by the Tour Managers at their discretion.
