23rD FIMMDA-PDAI Annual Conference at Barcelona from 6th to 9th April, 2024

In our quest to develop skill sets of market participants, FIMMDA-PDAI hold Annual Conference each year to discuss and deliberate topics of importance to the industry. This year the 23rd FIMMDA-PDAI Annual conference is being held during 6th-9th April, 2024 at Barcelona.

About Barcelona:

Barcelona City is on Spain's northeastern coast. Situated on the coast between the mouths of the rivers Llobregat and Besòs, and bordered to the west by the Serra de Collserola mountain range, it is one of the largest metropolises on the Mediterranean Sea.

With a rich cultural history, Barcelona is a popular tourist destination as well as a significant cultural hub today. In addition to holding prestigious conferences and expositions, the city is well-known for hosting the Summer Olympics in 1992. Additionally, this location has hosted a number of international sporting events.

With more than half of the Catalan region's labour and GDP coming from Barcelona, the city continues to be its economic engine. Barcelona is the primary biotech hub of Spain in addition to being a financial and commercial hub for southwest Europe. Barcelona is eligible to be classified as a global city due to its prominence in world politics and economy. According to the World Bank, Spain has the fifteenth-largest GDP, with a projected GDP rate of 1.5% in the year 2024 classifying it an advanced economy. Catalonia, one of the most economically developed areas of the nation, accounts for 19-20% of the national GDP, with the Barcelona region producing more than 35% of this total.

Barcelona is a multicultural city, with 20.2% of its citizens being foreign-born, mostly from China, Italy and Pakistan. Despite the fact that more than 200 languages are spoken there, only Catalan and Spanish are recognised as official languages in the city. Furthermore, it is home to the Generalitat de Catalunya and the Catalan Parliament, two of Catalonia's most important self-governing bodies.

Barcelona's long-standing ties to international publishing are further evidenced by its designation as a UNESCO City of Literature.

FIMMDA-PDAI Annual Conference:

Visa Checklist for Spain

As the Visa Process may take some time, please hurry with your applications with full details.

FIMMDA's Documents:

- Cover letter on company letter head with signed and stamped and name list of passengers having name/passport no / designation /relation with corporate.
- Company's Bank statements for Last 6 months attested (stamp and signed) by Bank on each page.
- ITR for Last 3 years.
- Company's MOA / GST / Certificate of Incorporation

Individual Documents of Traveler:

- Passport valid for next 6 months from date of tour completion and having at least 3 blank pages and one of page should be blank both the side + previous / old passports.
- Cover letter from Applicant on A4 paper (if employee).
- Four recent photos 35x45 mm white background with 80% face of photo photos should not be old and used in previous visa.
- Last 6 months updated Personal Bank statements with sufficient balance & attested by bank on each page.
- Last 2 years ITR Copy and pan card copy.
- For Employee Original Leave sanctioned with signed and stamp by authorized person on company letter head along with recent last 3 months' salary slips with Employee Id Card.

Time Taken:

Up to 15 working days post visa application submission at BLS

Optional Service at additional cost:

Premium Lounge - INR 3800/- Per Person

Remarks:

- All Delegates have to visit BLS center for Biometric.
- Require signature of Applicant on Application form, Authorisation form, Sworn Declaration form with Blue Ink Only
- The checklist must be submitted on back-to-back format only (without back-to-back copies being stapled to each other).
- All documents (excluding legal documents i.e., affidavit /agreement etc.) should be in A4 size.
- All documents should be in English, if any document is in other languages than English, that case it should be translated into English and notarised along with copy of origin documents.
- Embassy or Consulate reserves right to ask for further documentation at any point of time during visa process apart from listed above.

While Visiting BLS / Application Centre Applicants should Make sure their Palm must be free from Cuts and Mehendi or no colours on Palm / fingertips
