NOTICE is hereby given that *in terms of Articles 17 to 20 of Articles of Association of Fixed Income Money Market And Derivatives Association of India ("the Company"), every member shall be entitled to act and be represented through any one of his/its Authorised Representatives. A Member may also be represented, and may act or vote at any general meeting (e.g. AGM or EGM) through another member appointed as Proxy in a prescribed form.*

In terms of Article 20 of Articles of Association of the Company, no person shall be entitled to act or vote on behalf of any member or otherwise represent unless his name appears in the Register of Members as an Authorised Representative of that member or unless his name has been communicated to the Company as a proxy in terms of Article 19.

In view of the aforesaid provisions, all the Members are requested to strictly comply with the following :

1. To furnish not more than three names of its Authorised Representatives for being entered in the Register of Members in terms of Articles of Association of the Company.
2. To furnish the name of its Authorised Representative ("AR") who is entitled to attend and vote at the EGM. The AR shall produce/handover the Letter of Authority issued by the concerned Member-institution at the entrance of the EGM Hall along with the 'Admission Slip' duly filled in



OR to be signed in an Attendance Register kept at the entrance of the EGM Hall .

3. The appointment of Proxy, if any, shall be received by the Company not later than 48 hours before the commencement of EGM. That is, the Proxies shall be received by the Company at its Registered Office on or before 4:15 p.m. on November 25, 2025
