## SHORT SELLING OF GOVT OF INDIA SECURITIES

## Eligible liquid securities for the month of September 2024 (05-09-2024 to 04-10-2024)

As per Short Sale (Reserve Bank) Directions, 2018 issued by RBI vide Cir. <u>FMRD.DIRD.5/14.03.007/2018-19</u> dated 25-07-2018, eligible entities can undertake short sales in Central Government dated securities up to the permissible limits.

As provided in the directions, FIMMDA publishes every month, a list of liquid securities and limits applicable along with the permissible limits for other securities.

The liquid securities are selected based on the following criteria:

- 1. Total traded volume in the entire previous month: Rs. 5000 Crore and above.
- 2. Total number of trades in the entire previous month: 1000 and above.

As per extant guidelines limits applicable for short sale transactions are:

- 1. For Liquid Securities: 2% of the outstanding stock or Rs.500 crores, whichever is higher.
- 2. For Other Securities: 1% of the outstanding stock or Rs.250 crores, whichever is higher.

Security wise short selling limits based on details of outstanding stock as on 2<sup>nd</sup> September 2024 are given in Annexure.

Members are advised to note the same and ensure compliance of all other regulatory and internal guidelines applicable in this regard.
